

OFFER - CONTRACT ADDENDUM FOR RUSSIAN RUBLE PAYMENTS

LANGROOM LTD, registration number HE330757, represented by Director Mr. Dmitry Kochnev, acting ex officio, hereinafter referred to as "the Contractor", herewith offers the legal entity, and also the self-employed entrepreneur with whom the Contractor has concluded the Offer (hereinafter referred to as "the Customer") to conclude this Contract Addendum (Offer) to provide payments for English tutoring services in Russian rubles as follows:

TERMS AND DEFINITIONS OF THE CONTRACT ADDENDUM

- The Contract Addendum shall mean this Contract Addendum (Offer) for Russian ruble payments to the Contract (offer agreement) that can be found at <https://skyeng.eu/offer-agreement-premium-b2b>.
- The Acceptance (Accept) shall mean acceptance of the Contract Addendum (Offer) for Russian ruble payments which is equivalent to signing the Contract Addendum under the below terms and conditions.
- The Parties shall mean the Contractor and the Customer collectively, and separately -the Party.
- The Offer shall mean the contract (offer agreement) for English tutoring services that can be found at <https://skyeng.eu/b2b-eng-offer-prepayment> or <https://skyeng.eu/b2b-eng-offer-postpayment>.

1. Section «Tariffs» of the terms and conditions of the Offer is hereby amended and restated to read in its entirety as follows:

«Tariffs - the cost of a certain volume of Contractor's Services based on one or more (package) of lessons (lessons) lasting 50 (fifty) minutes with a Russian-speaking, Spanish-speaking or English-speaking Tutor. The Tariffs are specified in paragraphs 1.5.-1.7. in Russian rubles».

2. Section 1.5 of the Offer is hereby amended and restated to read in its entirety as follows:

«1.5. The Tariffs for companies which are <https://skyeng.eu/> website Clients are available at <https://skyeng.eu/offer-b2b-ruble-price-prepaid> or <https://skyeng.eu/offer-b2b-ruble-price-postpaid> due to the Offer chosen by the Customer».

The Tariffs for companies which are <https://skyengschool.es/> website Clients are available at <https://skyengschool.es/price>.

VAT is not included into the Prices above. For EU Clients VAT is a subject to reverse charge, for non-EU Clients VAT is not applicable, for Cyprus Clients VAT 19% is applicable.».

3. FINAL PROVISIONS

- a. This Contract Addendum shall be governed by the applicable legislation of the Republic of Cyprus.
- b. The official email address of the Contractor - companies@skyeng.ru. To Accept the Contract addendum the Customer shall provide the Contractor with the official e-mail letter with the request for ruble payments made by the Customer's official email address which was used in the process of Acceptance of the Offer. The Parties hereby agree that e-mail correspondence between representatives of the Parties via the email addresses specified under the conditions of this paragraph shall be legally binding, may result in beginning, changing or ending of certain legal relationship and, in the event of disputes, may be used as an evidence.
- c. Issues and definitions that are not directly regulated by this Contract Addendum shall be governed by the current legislation of the Republic of Cyprus and the corresponding Contract or Offer.
- d. This Contract Addendum is made in English, it shall become effective from the moment of its Acceptance by the Customer and shall be remain effective for the duration of the corresponding Contract or Offer.
